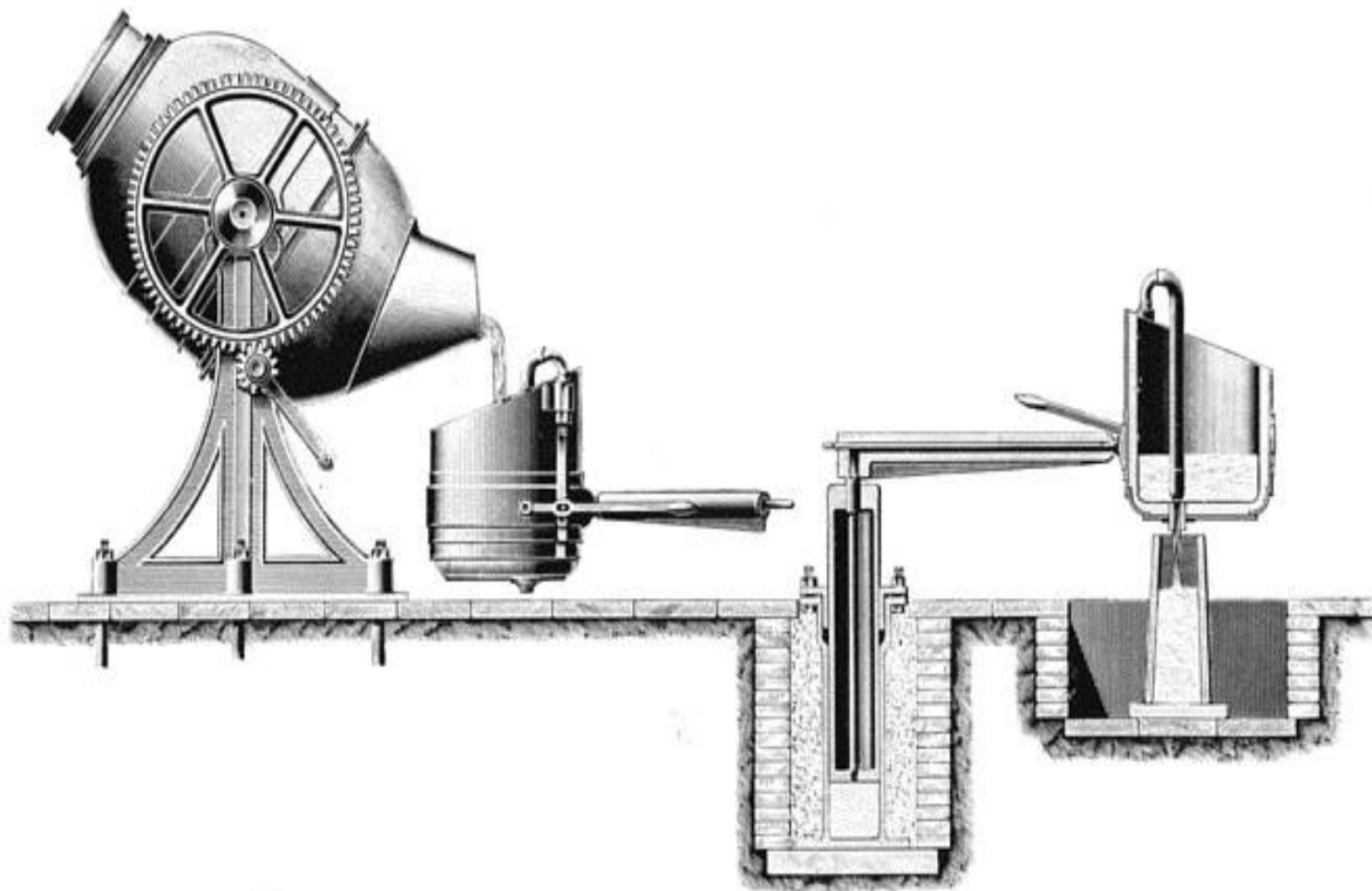
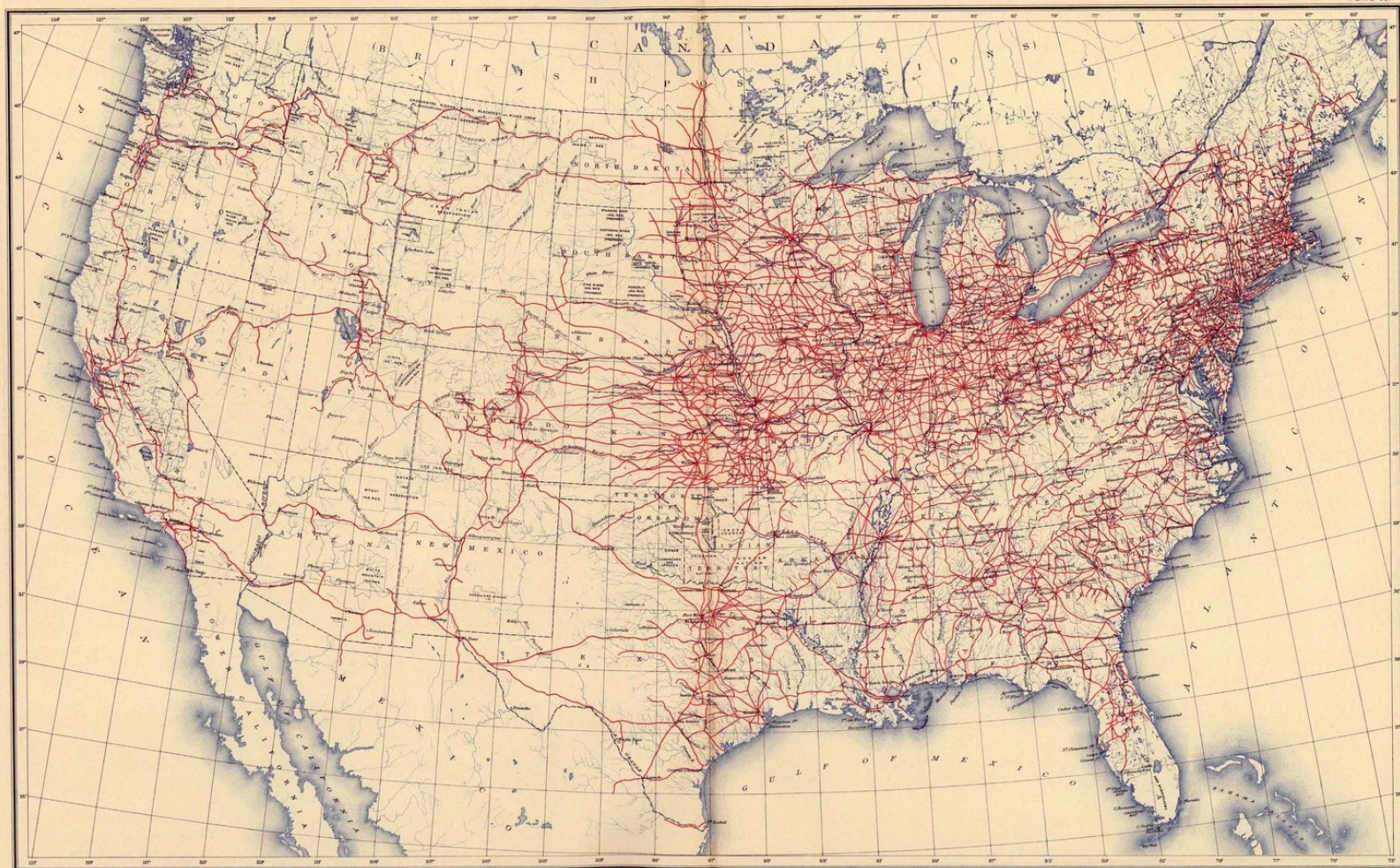


FIG. 44. EARLY FORM OF BESSEMER CONVERTING PLANT AT SHEFFIELD
